By passport style the following are general guidelines to follow:

- a close-up, showing your child's whole head and shoulders, looking straight into the camera
- recent (within the last 3 months)
- recognisable as your child
- taken against a plain light-coloured background
- printed at high resolution on photo quality paper
- showing your child's face, with no sunglasses or reflections from regular glasses
- with no head covering (unless for religious beliefs or medical reasons)

By requesting a card for your child using this form, you will be asking for them to be given access to free bus travel within Scotland.
